

Terms and Conditions

1. INTRODUCTION

1.1 Welcome to the www.vesmarket.com website. These Terms and Conditions govern your access and use of the Platform and the use of any services, information and functions made available by us at the Platform ("Services"). The place of arbitration shall be Malaysia. Any award by the arbitration tribunal shall be final and binding upon the parties.

7.1 In addition to any other legal or equitable remedies, we may, without prior notice to you, immediately terminate or revoke any or all of your rights granted under these Terms and Conditions.
